## Making an impact

Women in Property uses our position to influence at Government level. We are regular contributors to the Government's All-Party Parliamentary Group on Women in Work, commenting on Women Returners in 2016, Making the Industrial Strategy work for Women in 2018, and last year provided a submission for How to Recruit Women for the 21st Century. This year the Group is looking at Inclusivity and Intersectionality.

We recently submitted evidence to the 7th Inquiry of the APPG for Excellence in the Built Environment on the recruitment and retention of women in construction and presented to the Commission at Westminster, one of just eight organisations invited to do so. National Chairman, Mandy St John Davey was recently appointed to the Welsh Government Board Expert Panel Supporting Entrepreneurial Women in Wales. Earlier this year, Lorna Hamilton, Ann Allen and Nicola Barclay, all committed members of Women in Property, took their message to Holyrood, when they presented to the Scottish Parliament's economy, energy and fair work committee. In recent years we contributed to the Lord Davies Report on Women on Boards and to the HS2 Growth Taskforce.

## Women of Influence

Four members of Women in Property were selected for The Planner's RTPI Women of Influence 2019. Former National Chairman Brenda Jones, of Stornoway Port Authority, Nicola Barclay and Nickola Miller, both of Homes for Scotland and Constanze Bell, Barrister with Kings Chambers all made the final list. 337 nominations were submitted for 192 different women and the judges were asked to consider influence and impact, particularly in the last two years, relevance and topicality, location, variety and the 'X-factor', for stand out.

I had just taken my first malaria tablet when the realisation dawned on me... I would be joining five complete strangers to travel to Malawi to challenge ourselves to skill share with women in business, run STEM workshops with Rainbow Hope Secondary School and climb the 'island in the sky', central Africa's highest mountain, Mt Mulanje. Taking a deep breath and saying to myself #standtall, I thrived!

It was an experience of a lifetime working with Kate Webb from Orbis Expeditions, whom I originally met at the South West Summer Drinks reception last year. Kate's business is passionate about making tourism reach local communities in Malawi and finding sustainable ways to ensure travel is beneficial to developing countries. This adventure allowed

me to share my skills with others to support their business enterprises, which was inspiring and rewarding. Using simple exercises like making paper aeroplanes to teach about engineering was unforgettable - none of the pupils had seen or made one before.

Across our group we brought knowledge in business, finance, digital marketing, teaching and engineering/architecture. A fantastic bond was created across the week-long adventure and I left the 'Warm heart of Africa' with new enduring friendships.

## The open plan witch hunt

For as long as I can remember, there has been a witch hunt against open plan office environments. It seems that journalists trapped in poorly designed open plan offices act as what economist Edward Glaeser called "entrepreneurs of error". As they have been known to feed the public with headlines such as 'Does open-plan get the worst out of workers?', 'Open plan offices suck', '10 Rules for Surviving Your Open Plan Office' and my favourite 'Open plan offices were devised by Satan in the deepest caverns of hell'.

Now, it would be quite naïve to claim that the open plan solution is completely without challenges. In fact, I would never deny that an open plan office that is expected to support all activities from focused work to telephone conversations, mixed with poor acoustics and a limited variety of work zones, is an ineffective solution. But that does not mean the entire concept is flawed and that all open environments are bad.

In 2010 we launched the first independent assessment technique for occupier clients and their consultants to measure employee workplace experience. In the time since, we've measured how 3,750+ workplaces impact 525,000+ employees across 91



countries, arming CRE leaders with the insight they need to better tune workplaces to employée needs.

In 2018, 28 of the 971 workplaces we measured qualified for the coveted Leesman+ certification. These workplaces sport the highest employee satisfaction levels. Despite these workplaces being predominantly open, the employees have reported some of the best scores on individual focused work and noise levels that we've ever seen. These spaces also score well on informal work areas and breakout zones, and quiet rooms for working alone or in pairs, so it's all really about providing the right mix of spaces for different types of activites.

Only 2% of the employees in the Leesman+ spaces work in a private office. The fact that the remaining 98% report satisfaction levels that top the workplace charts suggests that the ire directed at open plan offices is misguided. Next time you encounter an unfriendly open-plan headline, just think fake news.
